SYNOPSIS

On February 22, 2025 one male subject exchanged gunfire with Kirtland Air Force Base Military Police personnel at 4849 Gibson Blvd

NARRATIVE

On February 22, 2025 at 0148 hours I was dispatched as backup to the intersection of Gibson Blvd and Truman St in response to an officer involved shooting. Comments on the call stated that Kirtland Air Force Base Military Police were involved in a shooting off base. One suspect was down, and MP's were requesting backup.

Upon arrival, I blocked all southbound traffic on Truman St at Crest Ave. I walked up to 4849 Gibson and observed multiple officers carrying the suspect to the street to get him away from a major gas leak at the apartment complex. Officer Arbogast began to render medical aid. I handed him one of my chest seals. Albuquerque Fire Rescue arrived on scene and stated that the suspect had no pulse. They began rendering medical aid.

At approximately 0430 hours one of the involved MP's was moved to my police vehicle. He was held in my custody until I was relieved by another unit at 0800 hours.

I conducted no investigation, and only blocked traffic for this scene. My OBRD footage will be uploaded to evidence.com. This concludes my involvement reference this call.

SYNOPSIS

On February 22, 2025 I was dispatched to 4849 Gibson Blvd SE at 0150 hours in reference to a cover assistance call. Comments on the call stated Kirtland Airforce Base was requesting assistance from Officers reference shots had been fired and one individual was "down".

PR MARY REPORTER

NARRATIVE

On February 22, 2025 I was dispatched to 4849 Gibson Blvd SE at 0150 hours in reference to a cover assistance call. Comments on the call stated Kirtland Airforce Base was requesting assistance from Officers reference shots had been fired and one individual was "down".

Upon arrival I observed two military police vehicles just north of the intersection of Truman St SE and Gibson Blvd SE. There were six Security Forces members present upon my arrival who indicated there was a deceased male behind a red sedan. I observed a male in a red hoodie and black pants laying on his back who appeared to be unconscious and with visible injuries on his body.

While waiting for additional Officers, the Security Forces members were taken away from the scene and inspected for injuries. Security Force member William Fraizer stated he was shot on his right hand and was rendered aid.

Officers then approached the male who was said to be deceased to render aid but he was past life saving measures. Due to a gas leak the deceased was moved away from the leak and placed on Truman St SE while Albuquerque Fire and Rescue (AFR) shut off the gas in the building. AFR also rendered aid to the male individual but he was beyond help.

William Fraizer was then transported to UNMH due to his injuries while the rest of the Security Forces members remained on scene. I interviewed Sergeant Cameron Chaviers and asked him what had occurred prior to our arrival. Sergeant Chaviers stated he made contact with an individual by the name of Brion Teel Scott at the Truman Gate on the Kirtland Airforce Base at approximately 0042 hours. Sergeant Chaviers states Brion presented his military identification card to enter the base but when Security Forces checked the registration and insurance on his vehicle it appeared to be suspended. Chaviers states that per policy they are to tow vehicles without valid registration and insurance. Security Forces then began to inventory the vehicle where they found a bag of marijuana in the trunk underneath the spare tire compartment.

Sergeant Chaviers states that as they inform Brion that he is going to be detained he runs from them headed northbound on Truman St. Himself along with, six other Special Forces members follow Brion to 4849 Gibson Blvd SE where they apprehend him. Sergeant Chaviers states that for approximately 5 minutes they give Brion commands to comply but he refuses. Chaviers then states Brion begins firing shots towards him and the other members causing them to return fire. Chaviers then informs his Base Defense Operation Center (BDOC) of the situation over the radio and requests Officers to the scene. Chaviers and the other members standby until Albuquerque Police Officers' arrive on scene.

Subsequently, I interviewed Lieutenant Jackson Vincent who relayed the same information regarding their initial contact with Brion. Lt. Vincent stated that once they followed Brion to 4849 Gibson Blvd SE, Brion hid behind a sedan that was parked at the address listed. Lt. Vincent stated that his team attempted to get Brion to comply for several minutes by giving him commands which he refused to follow. During this time Lt. Vincent and four other members where taking cover behind a wall just south of where Brion was hiding. Two other members where north of Brion behind a black SUV.

Lt. Vincent states he hears a "click" which to him sounded like a firearm was attempted to be discharged but malfunctioned. He then hears shots being fired and states he returns fire as well. After the gunfire ceases Lt. Vincent sees Brion fall to the ground. At the same time he also hears William Frazier who was north of him say he had been shot. Lt. Vincent and the rest of the members move to the north side to join the rest of the members. Lt. Vincent observes that Brion had crawled from behind the sedan and moved east towards Truman St and was now laying in front of a red sedan. Lt. Vincent states himself and the rest of the members hold their position until APD Officers arrive.

Lastly, I spoke to Michael Crossland who resides at 4849 Gibson Blvd SE in apartment #25. Michael and his roommates Madison Daniels and Jacob Honea state they were in their home when they heard yelling just outside of their apartment. Shortly after he hears approximately 15-20 gunshots and immediately dials 911. Michael states there is a small break after the gunshots but shortly after he

hears about 12 more gunshots. After the last gunshots are fired he hears more yelling and says he heard someone say, "I got hit." Michael states there are at least two gunshots that went through his front door and an additional two on one of the walls in his apartment. Michael gave his permission for his apartment to be processed. Fortunately, none of the occupants in the home were injured.

For the remainder of my time on scene Sergeant Chaviers remained in my unit he was processed by the Crime Scene Specialist. At approximately 0815 hours I was relieved by another Officer and Sergeant Chaviers was relocated to his unit.

This concludes my involvement in the case.

SYNOPSIS

On February 22, 2025, I assisted Kirkland Air Force military police after a shooting occurred near the intersection of Truman St SE and Gibson Blvd SE.

PR MARY REPORTER

NARRATIVE

On February 22, 2025, I was dispatched to the intersection of Truman St SE and Gibson Blvd SE, in reference to an assistance call. Comments advised that Kirkland Air Force Base was requesting officers due to a male having a firearm. Comments also advised that while on the phone dispatch heard a gunshot be fired. Comments would later advise that a second caller was contacting police advising of gunshots being heard outside his residence.

Upon arrival near the intersection, I located military police vehicles parked mid-block on Truman St SE. I then exited my vehicle and witnessed military personnel providing medical aide to a member of the military police. I then gathered information and was advised that a male suspect was shot and laying behind a red two-door vehicle near the driveway of 4849 Gibson Blvd SE. An arrest team was then set in place and officers moved up to attempt and render medical aide. As officers approached a black male adult, wearing a red hoodie, and blue sweatpants, was seen laying in front of the red vehicle. The male had multiple gunshot wounds and officers proceeded to begin applying chest seal and began life saving measures. Shortly after medical personnel arrived at the scene and took over life saving measures.

I was then asked by Sergeant A. Gonzales (6578) to have Kylema Dixon sit in the back of my patrol vehicle due to her being involved and needing to be interviewed. Custody of Kylema would later be transferred to Officer L. Barraza (6795) and Officer Barraza would relieve me from my post.

While at the scene I also spoke with Michael Loomis, who is the manager of the Taco Bell located at 4901 Gibson Blvd SE. Michael advised that there was brief video footage of the incident and an evidence.com link was sent to Michael to upload the footage.

This concluded my involvement in the case. My lapel was uploaded to evidence.com at the Southeast Substation.

SYNOPSIS

On 02/22/2025 officers responded to 4900 Gibson Blvd SE in reference to a Cover Assistance call made by Kirkland Airforce. I interviewed Kylema Dixon who was involved in the shooting.

NARRATIVE

INITIAL CALL:

On 02/22/2025 officers responded to 4900 Gibson Blvd SE in reference to a Cover Assistance call made by Kirkland Airforce. I was told that I would be help evacuate the adjacent apartment after the shooting had opened a gas line.

ON SCENE:

I arrived at the listed crime scene, I help put up crime scene tape and interviewed one of the participants in the shooting. I observed three Airman standing outside the Tacobell, on the sidewalk. I spoke with Kylema Dixon. Going into the interview I was not aware that she was involved as thought she was a witness.

Kyema told me the following:

- She was called to the Truman Gate for a vehicle with an expired registration.
- She was told they were going to tow the vehicle and the other Airmen conducted an inventory, while doing so they found weed in the trunk. That was enough for an apprehension.
- The suspect (William) took off running on foot.
- The other Airmen followed and she was told to grab a vehicle, she got into a vehicle with Clarkston.
- William was by himself in the corner by the car, as the Airmen asked him to show his hands and to not reach for anything.
- William kept repeating that he couldn't do that.
- William fired rounds, Kylema was standing number two in the stack and saw the flashes from the muzzle.
- 10 rounds were shot by William before rounds were fired back at him.
- William ran from behind a vehicle and his arm was hanging limp.
- Their Sergeant was shot in the hand
- They shot back until there was not more threat to their lives.

On February 22, 2025 I assisted Kirtland Air Force Base.

NARRATIVE

On February 22, 2025 I was dispatched to the intersection Gibson and Truman in reference to Kirtland Air Force Base (KAFB) needing cover assistance. Comments on the call stated KAFB asking for officers, Taco Bell, possible forearm, BMA, 511, red hoodie, red backpack, black jeans. Shots just fired. Suspect is down. In progress, caller advised of same information, gunshots near Taco Bell. Operator can hear more gunshots while on phone. Subjects are yelling that someone was "hit."

Upon arriving on scene, there was a noticeable gas leak and a subject down on the northeast side of 4849 Gibson Blvd SE. A force array was assembled to approach the male to render aid. Officers carried the male to Truman St to start rendering aid. Rescue arrived shortly after and took over.

I then assisted in locating the firearm, vacating apartments, and securing the scene. I then blocked eastbound traffic from Gibson and Jackson.

SYNOPSIS

On 02/22/25, I assisted Kirtland Air Force Base officers after they were involved in a shooting and are requesting officers.

NARRATIVE

On February 22, 2025, I was dispatched to an assistance call located at Gibson Blvd SE and Truman St SE. Comments stated that Kirtland Air Force Base is asking for officers to assist after shots have been fired.

PR MARY REPORTER

Upon arrival, I observed other officers on scene as well as Kirtland Air Force uniformed soldiers. I observed a hissing noise that was coming from an unknown gas leak where the subject was at. The gas leak was extremely strong as I can smell the odor of the gas from near the Taco Bell. I was informed from other officers on scene that the suspect was deceased, but had not been approached and aid had not been rendered. A force array was quickly established to approach the suspect, who was laying in the northeastern driveway of 4849 Gibson Blvd SE. I approached the subject who was lying face up and was non-responsive. At this distance from the gas leak and the odor of the gas being very strong, I moved the subject from where he was lying to the street. I started to render aid and cut his upper clothing off. I observed multiple gunshot wounds to his upper torso. At this time, Albuquerque Fire Rescue arrived and started to take over first aid.

I let AFR provide aid and I started to secure the scene with crime scene tape. While doing so, I observed a firearm that was on the floor on the west side of the driveway that the suspect was in. The suspect and the firearm were not near each other. I finished securing the scene with crime scene tape and went to go help hold outer perimeter on Gibson Blvd SE closer to Jackson St SE.

I held the perimeter spot until ordered to do otherwise. This concludes my involvement in this incident. My OBRD footage was tagged and uploaded into evidence.

SYNOPSIS						

On February 22, 2025, at 4849 Gibson Blvd SE, in the County of Bernalillo. I assisted Kirkland Airforce Military Police officers regarding a shooting that their military police were involved in.

NARRATIVE

On February 22, 2025, at 4849 Gibson Blvd SE, in the County of Bernalillo. On the listed time and date. I responded to a call for service regarding Kirkland Airforce Dispatch requesting APD police officers to assist them in an active shooting that involved their Military Police (MPs) Officers.

Upon arrival, I observed two military police-marked units parked on the Northeast Side of the listed address. I observed that there were 6 MP's that were taking cover behind a dark in color SUV. The MPs were pointing out that the male subject they had shot was lying in front of a red coupe car. I observed that a male subject wearing a red jacket and black pants and had visible injuries to his chest area was lying on his back and was not moving.

I was told by one of the MPs that one of their guys was shot in his right hand. I observed that a gas line from the listed address had been hit and was leaking gas. The gas leak was bad and could be heard very loud due to the immense pressure. The smell of gas could be smelled from the roadway, and I advised all MPs to get to the other side of the roadway and clear the area. Due to the gas leak in the area, the deceased was moved closer to the sidewalk away from the gas leak.

I contacted APD Dispatch over Radio Communications and advised them to have paramedics step up and run code due to two male subjects being shot. APD Dispatch was also advised about the major gas leak in the area and relayed that to firefighters en-route to the scene. I requested that the real-time crime center find a reporting party of the listed address. So residents could be warned and start to evacuate the area.

Through my investigation, the male subject who was shot by the MPs was later identified as Brion Teel-Scott. The MP who was shot in the right hand was identified as SGT William Frazier, Frazier was taken to the UNM Hospital where he was treated for his injuries.

I started speaking with SGT Cameron Chaviers who advised me that Brion was entering the Kirkland Airforce Base through the Truman entrance. Cameron expressed that Brion was driving a vehicle that did not have valid registration and was showing suspended on their database system.

Cameron explained to me that Brion started to become hostile and uncooperative with him and other MPs on the scene. Cameron said that Brion's vehicle was going to be towed and that through their standard policy and procedures, Brion's vehicle would have an inventory check conducted. Cameron mentioned that through the inventory search drugs were found in Brion's vehicle.

Cameron mentioned that Brion was waiting in a friend's vehicle and that when MPs started to approach him and took off running from them. Cameron stated that MPs caught up to Brion and that Brion shot at MPs first and shots were fired. End of statements from Cameron, reference my OBRD for further information.

I spoke with Michael Clarkson who is an MP for the KAFB. Speaking with Michael, he advised me that Brion is known to be hostile towards MPs. Michael told me that Brion had expired registration, and that MPs were going to cite him for his traffic violations. Michael mentioned that Brion was becoming more agitated as he was talking with MPs and wanted to leave.

Michael advised that drugs were found in Brion's vehicle and that he would now be detained. Michael explained that when MPs tried to confront Brion he fled from them. Michael did not disclose to me how he arrived on the scene but advised that shots were fired and that he saw Brion rack his black handgun and started to shoot at MPs. Michael informed me that he did apply a tourniquet on SGT William Frazier's arm that he had been shot. End of statements from Michael, reference my OBRD for further information.

I spoke with Jackson Vincent who is an LT MP in the KAFB, Jackson told me he was at the B-Dock Operations Center just south of the front gate. Jackson was advised that Brion was refusing to get out of his vehicle. From Jackson's understanding, they have had past incidents with Brion, and he is known to get in trouble with MPs.

Jackson was advised by front gate MPs that the vehicle that Bryon was in had an expired license plate. Due to Brion not wanting to obey front gate MPs commands to exit his vehicle, Jackson said he wanted to help assist with the situation. By the time Jackson arrived, Brion had complied and exited his vehicle and was escorted to the visitor center with other MPs.

At this time, Jackson was informed that they were going to do an inventory check on Brion's vehicle due to policy before a tow truck comes for the vehicle, it needs to be checked. Jackson advised that Brion's vehicle had a strong odor of Marijuana coming from inside. Jackson stated that SGT Frazier had found the green leafy substance in the trunk of Brion's vehicle.

Jackson said that LT Densley has photos of where the green leafy substance was located in Brion's vehicle and the baggies in the green leafy substance were found. Jackson explained that LT Densley took the photos with his work phone but was not able to provide a number for me at the time. Jackson advised that SGT Frazier and Sgt Chaviers made the decision to detain Brion and had advised MP Michael Clarkson that Brion was going to be detained for the finding of drugs in Brion's vehicle.

Jackson stated that he and SGT Frazier and SGT Chaviers started to approach Brion and that is when he started to flee on foot from them. Jackson expressed that he followed Brion and was now in a foot pursuit with Brion and other MPs. Jackson advised that he was the closest to Brion in the foot pursuit, Jackson mentioned that he was giving out verbal commands for Brion telling him to "Stop and show his hands."

Jackson stated that Brion was not stopping and was still fleeing from MPs, a MP Marked Unit was able to pass Brion who had already passed the intersection of Truman and Gibson. Jackson informed me that the MP Marked Unit had cut Brion off and was now in front of Brion, which caused Brion to turn left into the property of 4849 Gibson Blvd SE.

Jackson said that Brion was in a small parking area and was taking cover behind the front end of a black dark grey sedan vehicle parked in the area. Jackson stated that he was positioned behind the black sedan where Brion was and had about three other MPs behind him. Jackson expressed that he and SGT Frazier were giving Brion verbal commands for about three and five minutes but were unsure.

Jackson told me that Brion yelled to them that they did not have any jurisdiction and to call APD and requested APD about 7 times. Jackson said that Brion told them that if Jackson backed up, he would show his hands and be compliant. Jackson stated that he started to back up and that is when he heard a click that sounded like a weapon firing like a striker landing forward. Jackson expressed that he did not see Brion pointing a firearm at him and never saw a gun.

Jackson expressed that shots were fired, and I was not able to get the rest of Jacksons story after that. I had to speak with the on-call Homicide unit detectives who arrived on the scene and were ready for me to de-brief them regarding the call for service. End of statements from Jackson, reference my OBRD for further information.

I spoke with SGT Frazier, and he stated that Brion's license plate on his vehicle was run and showed that it was expired and suspended. SGT William explained they were going to give Brion a traffic ticket and tow his vehicle. While conducting an inventory check on Brion's vehicle. MPs located and found a green leafy substance in the trunk area, where the spare tire is located.

At that time KAFB MPs tried to detain Brion and he started to flee. SGT Williams stated that he got into the MP Marked Unit and followed about three or four other MPs who were in a foot pursuit with Brion heading Southbound on Truman. SGT William advised that he and other MPs caught up to Brion and shots were fired.

SGT Williams went up to Brion who was now lying against the south wall of the address of 4849 Gibson Blvd SE. SGT Williams explained that he approached Brion, he kicked the gun that Brion had away with his boot. SGT Williams said that Brion started to move and that he backed away and then shots were fired again. SGT Williams had backed away and got in formation with his other MPs and noticed that he had blood coming down from his right hand. End of statements from ST Williams, reference my OBRD for further information.

Other KAFB MPs involved that I did not speak with were Kylema Dixon, and Jeremy Amar. Reference other APD officer's supplemental reports regarding any statements from the listed subjects, that I did not speak with.

Just note that during this time I was still being advised if APD would take over this call for service or if the FBI FEDS would take primary investigators. I was informed at the end of de-briefing with APD Homicide Unit Detectives. The FBI FEDs would end up handling this incident and would take primary over all investigations of this incident.

Just note that at the time APD was notified we would take primary over this case. A Crime Scene Investigator was called out to the scene to process the scene. All Kirkland Air Force MPs were detained and placed into marked units and their duty weapons were recovered and placed into Officer A. Martinez's marked unit.

Officer D. Romero who was at the UNM Hospital with SGT William Frazier advised that he was in stable condition with non-life-threatening injuries. SGT Frazier was later discharged from the UNM Hospital and transported back to the original crime scene by Officer D. Romero.

I was informed by Officer A. Martinez that subjects she had spoken with at the Taco Bell. Advised her that they lived at the listed address and had gunshots go through their apartment and possibly one of their vehicles. Reference Officer A. Martinez's #7721 supplemental report for further information.

Officer E. Munoz #5993 was able to speak with the Taco Bell Manager and get access to the security cameras in the area. An Evidence link was sent to the Taco Bell Manager to upload the security footage of the incident. Reference Officer E. Munoz's #5993 supplemental report for further information.

At this time this report will be sent to the Homicide Unit for Case follow-up, this concludes my involvement.

on February 22nd, 2025 at approximately 0147 hours, I responded to Gibson Blvd Se and Truman St Se in reference to Kirkland Airforce Base Military Police being involved in a shooting.

I arrived on scene and was informed that there was a gas meter struck with possible gunfire and was leaking large amounts of gas. Officers pulled the male who was struck away from the gas and onto the sidewalk. Life saving efforts were made by Officers and Albuquerque Fire and Rescue but the male did not survive.

At this time Albuquerque Fire Department arrived on scene and began to shut the gas off. I began to manage the scene as I was the supervisor in charge of the incident. I arranged officers for an inner perimeter and also an outer perimeter. I notified the on duty Lieutenant who came to assist.

Officers separated 6 soldiers in their units. A Crime Scene Supervisor made this a homicide call out and detectives started our way. We continued to hold the scene.

I was later advised by Sgt Stockton of the homicide unit, that the FBI was going to be handling the investigation. Once day shift units started their shift, I relieved the night shift units and Sgt Chris Leeper relieved me. That concludes my involvment in this case.
